This role supports the effective implementation of Fiji's Safety Oversight System within the USOAP audit areas relating to Flight Operations (OPS), Airworthiness (AIR), and Personnel Licensing (PEL) for OPS/AIR. The position assists in ensuring compliance with ICAO Standards and Recommended Practices (SARPs) through research, monitoring, documentation, coordination of oversight activities, and supporting the development and maintenance of aviation standards, guidance material and safety oversight systems.

The role reports to the Senior Officer Standards & Compliance- Air Safety and will be responsible for fulfilling the following critical outcomes:

- Supports Delivery of Standards & Compliance Department functions
- Support USOAP audit activities and compliance
- Effective contribution and support to the Standards & Compliance Department
- Reporting & Information Management
- Stakeholder coordination and Safety Awareness
- Teamwork & organizational support

To excel in this role, you **must** have:

Qualification

- A Diploma in Aviation, Civil/Airport Engineering, Computing, Management/Planning/Policy/ or similar field. A relevant technical qualification (aviation licence) in Flight Ops or Airworthiness may be accepted in lieu of a first-level university diploma.

Experience & Knowledge

- Minimum 5 years relevant aviation industry experience;
- Proven experience in meeting and exceeding the organisation's strategic goals.
- In-depth knowledge of ICAO Conventions/Protocols, ICAO Annexes/ Documents/ Manuals and ICAO USOAP-CMA
- Experience researching matters including the ability to interpret and understand complex regulations and legislation.
- Experience in performing assessments or audits;
- Proven ability to develop and implement new and improved procedures and processes, report writing and preparation of complex documents.
- Experience in data management including extracting and reporting on data.
- Experience coordinating/undertaking activities to meet key project delivery timeframes.
- An understanding of aviation language, across areas such as licensing, aircraft operations, airworthiness of aircraft

Skills

- Demonstrated high-level of skills in the use of Microsoft Office Suite (i.e., Word, Outlook, Excel, and PowerPoint) and other relevant computer software (e.g. Nitro, Adobe Acrobat);
